An application is being made at the end of June for around £350,000 grant to contribute to the purchase by the community. To be successful that application has to be backed by tangible community support. The funding body consider this support to be most clearly reflected in the number of members that we have.

You can strengthen the bid by becoming a Member – a Founder Member. This involves the purchase of 20 £1 shares in the community business.

Joining is easy – and you become a shareholder in the Haven Community Inn of the future.

In short, tangible community support reflected in membership numbers is critical to unlocking the funding that we need to take the Haven in to Community ownership
